The Applicant hereby waives any claim for damages because of non-acceptance of this application, which the landlord/owner or owner's designated agent may reject.

A SECURITY DEPOSIT equal to one month's Rent (unless otherwise agreed upon) is due and payable on or before the effective date of the lease. This security deposit is payable to RE/MAX Realty Group if they manage the property. Please consult with your agent. If the Applicant enters an agreement to lease a furnished unit, an additional deposit will be required not to exceed one month's Rent. If the Applicant enters an agreement to lease a pet-friendly property, a pet deposit will be required for each pet unless such pet qualifies under §5514 of the Delaware Landlord Tenant Code.
